- OCT 11-Ship workers inoculated near 100% by STL produced flu vax

Church Closures: Yes.

Health Official: Dr. J.S. McBride, Commissioner of Health

Masks: Yes. (OCT 28-NOV 12) *Commissioner also recommended six layer masks instead of standard four layers of gauze. Courthouse records cited decrease in marriages and increased divorces coinciding with mask orders. Mask fines were \$5.00.

Military Connections: Camp Lewis 45 miles south of STL in Pierce County & U of Washington Student Army Training Corps & Student Naval Training Corps

Primary Strategies: Initially, it was closures and strict enforcements then by OCT 28 it was masks.

School Closures: Yes. (OCT 6-NOV 14)

Stats: Death Rate=414:100K, over 1,400 deaths from SEP 1918-FEB 1919
